This year, the Council has invested a further £1.5m in the highways service to undertake line painting, sign cleaning, vegetation clearance, drainage repairs and resurfacing, all of which further improve the safety of our roads. Road markings have been, and continue to be, refreshed and repainted in many locations and in particular, picking up on safety markings such as stop lines, give way markings and junctions where these have faded as well as centre and edge lines and other markings. This will help ensure the markings are visible so that drivers clearly see them. North Northants Highways

				have regularly communicated through social media where they have undertaken this work. As part of our routine maintenance programme, our Highway Inspection Team regularly inspect all highways throughout North Northamptonshire to identify road marking that require replacement, as well as any other defects. These are then programmed as part of a wider programme of road marking replacements to ensure they remain prominent,

To ensure these activities are being undertaken in accordance with our Highway Service contract, we are employing highways contract inspectors/auditors whose remit is to ensure that the activities expected and promised as part of the Highway Service Contract, are being delivered by Kier. NNC is committed to dealing efficiently with housing repairs reported to it by its tenants. All repairs are categorised as emergency (24-hour response) or non-emergency. During October 2022, the Housing Property Services teams completed 956 emergency repairs and 1239 non-emergency repairs and since the beginning of the financial year have completed an average of 823 emergency and 1173 non-emergency repairs each month, which is in keeping with the amount of new repairs reported. Non-emergency repairs are largely dealt with in date order, although where

There remains a challenge to tackle the backlog of repairs NNC inherited as a result of the COVID lockdowns where operatives could not enter tenant's properties and were utilised on other work such as void properties instead. An action plan has been developed to address the backlog which has included a complete review of all outstanding repairs in order to omit duplications and cluster by type and neighbourhood. Completion of the plan requires additional revenue investment from within the HRA and options to secure this are being considered as part of the MTFP for the HRA. I am delighted that Pen Green have been selected as the Stronger Practice Hub for the East Midlands. For over 37 years, children and families in North Northants have benefited from their wealth of experience in delivering high quality education and support, thus contributing to better outcomes for our children.
				Most children missed out on some early education during the pandemic which means they had less opportunity to socialise and develop self-regulation skills and their physical development was negatively affected. The challenges facing providers are numerous, including financial implications, staff retention issues but also ensuring they are well equipped and trained to support the variety of needs children are presenting with when they join their

The Stronger Practice Hub initiative seeks to address the impact of the pandemic on young children by sharing good practice and building lasting networks. Pen Green are nationally recognised as a centre of excellence and we are lucky to have them as part of our Early Years provision in NNC; the whole of the East Midlands will benefit from their research evidence, ability to share good practice and support beyond their own settings and localities. We congratulated Pen Green when we heard the news and we congratulate them again on successfully being appointed as one of only 18 Practice Hubs nationally. As a council, I think we need to recognise the huge amount of progress and work which has happened since vesting day in April 2021. This has involved difficult decisions which aren't always agreeable with everyone but are important for the longer-term ambition of the council. Since April 2021, Executive have made 239 decisions and our Full Council 55. We are aware that some residents park on grass verges where parking is restricted within their neighbourhood. Unfortunately, this can lead to unsightly damage to the verges and, in some rare cases, may even damage utilities buried in the verge. Although parking on verges itself is not an offence outside London (unless it causes obstruction or is a heavy goods vehicle), as a highways authority we do discourage this behaviour where it is a concern for residents through additional signage and by working with local Members and parish councils. If the Councillor would like to notify us of any locations of concern, the highways service would be happy to discuss it further with him. Should legislation be introduced to permit us to enforce a ban on pavement and verge parking, we would actively consider that.

Where bus shelters have been installed by developers as part of their works on new roads or on existing roads, they remain the responsibility of the developer until the road is adopted or the works are signed off. At which point they either become the Council's responsibility within the highways service, or they become the responsibility of another party in accordance with the relevant agreement. For instance, in some cases it is agreed that shelters will become the responsibility of the parish council. The Council charges commuted sums for the on-going management and maintenance of the shelters where it will be a responsibility for them.

The teams work collaboratively to support pupils and families to identify and access the right education placement to meet needs. The case against Michigan Construction Limited regarding the unsafe building situated on land off Jobs Yard, Kettering is scheduled for trial for four days commencing 30th May 2023 at the Technology and Construction Court in Birmingham. As a council we do appreciate the pressures on all public bodies with raising energy costs, which also significantly affect this council, however, we do not see how we could make such a payment to parish councils, where the volume of street lights differs and which, in turn, could lead to expectations from other local bodies and further financial pressures to this council. Parish Councils may also choose to precept for these additional costs at their budget setting process.

Page 18	Councillor Lyn Buckingham 23/01/23	Councillor Matt Binley	At the Executive of 12th January I spoke on the KPI report on void turnarounds, in response CIIr Binley made serious allegations regarding voids at the former Corby Council and not reporting/accounting of these correctly, suggesting 500 void properties were wrongly accounted for, what is the evidence of this?	To clarify, the topics raised in this question regarding voids reporting in Corby and the issue of over 500 voids were 2 separate matters. Firstly, the service that transferred from Corby Borough Council measured voids turnaround times by not counting a 'safety period' which was a number of days at the end of the process before the keys were handed to Landlord Services for the property to be let. Whereas the service in Kettering measured voids turnaround time from 'the date of keys into the service to the date of keys out to the new tenant', the latter is recognised as industry standard. The Housing service has introduced a standardised end-to-end process for the management of voids which involves all the relevant service leads, consistent measurement and reporting of data is critical to this. As a result, the moving to standardisation of the reporting, in June this appeared to show an uplift in the Corby voids by 31% as a result, however this wasn't a sudden increase, it was a reflection that properties that were not previously reported in the Corby area were now captured within the reporting. With regards to the statement regarding 500 voids, this refers to the historic performance of void management within the previous sovereign council. Whilst historic performance was referenced, the situation was improved over a number of years, however it was referenced at the meeting to show current performance in comparison to that previous

Has levelling up been paused or forgotten in this county and will there be a report to give an update on what work has been done so far?	NNC officers sought immediate feedback on why our bids were unsuccessful. We have been told that the LUF was over four times oversubscribed with over 500 applications. NNC has informed projects leads of the outcome. Officers have asked for detailed feedback on the two bids and scoring. Once received, this will help NNC to understand why the bids were not successful and importantly next steps in relation to the individual projects ahead of any further funding opportunities. The Council continues to invest in left behind areas, including investment in new street lighting in Olympic Way, and forthcoming tree planting as part of the Local Authority Treescape fund programme. Further plans continue to be developed following up the actions identified in the scrutiny review. There have also been multi-agency and partnership approaches, working with the OPFCC on initiatives such as the Safer Streets Lite in Kingswood and Safer Streets in Queensway.

NNC is working closely with DWP and other partners to put in place a package measures to help people impacted by the job losses. On 24 January, the Council held its latest NN Job Club in the Corby Cube. This initiative is designed to help people get the support they need to find employment including CV writing, interview skills etc. DWP and NNC have also arranged a Job Fair, again at the Corby Cube, on 2 February. This will showcase some of the job opportunities available locally and within commuting distance to maximise the mix of opportunity. Up to 25 employers are due to attend, including Ball Corporation, VPK packaging, North Northants Council, Taste Original, TATA Steel and SERCO as well as other support organisations such as the National Careers Service. Similar events will be organised over the coming weeks and months along with other measures following discussions with DWP and other partners. NNC will continue to do all it can to assist people who have been impacted by recent job losses working in partnership with DWP.
