#### 1. Purpose of Report

1.1. To obtain the Committee's decision in respect of an application to Review a Premises Licence for Little Europe, 15, Midland Road, Wellingborough.

#### 2. Executive Summary

2.1 The application to review the Premises Licence was advertised in the normal way and received no representations. Following receipt of the application to Review the licence, it became apparent that the licence had been surrendered. There is therefore no longer any licence to review. There is no legislative provision for withdrawing an application to Review a licence or to dispense with the hearing.

#### 3. Recommendations

3.1 The Sub-Committee is recommended to note the report.

#### 4. Report Background

- 4.1 An application to Review the Premises Licence held for Little Europe under the Licensing Act 2003, was received from the Police on 12th April. The application refers to the sale and storage of smuggled tobacco products. A copy of the application is included within Appendix A.
- 4.2 The application to Review the licence is on the grounds that the licensing objectives, as prescribed by Section 4(2) of the Act, are not being met. The relevant licensing objective is;
  - the prevention of public nuisance;
- 4.3 The application to Review the licence was advertised in the normal manner and did not attract any representations from other Responsible Authorities or Interested Parties.
- 4.4 The Licensing administration team received notification from the licence holder on 24<sup>th</sup> March stating that he surrendered the licence. Unfortunately due to resource shortages within the team, this notification was not shared with the licensing enforcement team and the Police until an acknowledgement letter was sent out on 14<sup>th</sup> April. A copy of this letter is included within Appendix B.

#### 5. Issues and Choices

- 5.1 The Licensing Act 2003 does not include a provision for an applicant to withdraw an application to Review a premises licence once submitted. Therefore the application had to be administered and advertised in the normal manner. There is also no provision to dispense with a review hearing, even if all parties are in agreement that it is unnecessary. Therefore although there is no longer any licence in place to be reviewed, a hearing is still required to consider the matter.
- 5.2 Since there is no licence in place for the premises to review, Members are requested to note the report.

| I act on behalf of the Chief Officer of Police for Northampton shire, Mr Adderley. He has delegated responsibility and authorised me to act on his behalf regarding representations made by Northamptonshire Police to Licensing Authorities across the county of Northamptonshire. |
| Northamptonshire Police call for the Review of the Premises Licence for Little Europe under the Licensing Objective of the Prevention of Crime and Disorder.  |
| This Review relates to the sale and storage of smuggled tobacco products at the premise, this undermines the licensing objective of the Prevention of Crime and Disorder.   |

- 1) In December 2021, Northamptonshire Police (Licensing Department) were contacted by the Anti-Illicit Trade Operations Manager for Japanese International Tobacco (JTI) UK responsible for Western Europe.
- 2) JTI UK had received information that the sale of Counterfeit/Illicit Tobacco products were at high levels in Northamptonshire.
- 3) In response to this information JTI UK visited numerous retailers throughout Northamptonshire to establish if the information was correct.
- 4) Test purchases were undertaken at multiple premises with the Test Purchaser purporting to be a customer and asking whether 'cheap cigarettes' were sold.
- 5) All transactions were recorded, and any items purchased were exhibited with their integrity and continuity maintained to a criminal justice standard.
- 6) The majority of the purchased tobacco products have been examined by JTI UK specialist seizure and analysis staff, some items were JTI products, but duty had not been paid, the others were not JTI products but again had no duty paid or were possibly counterfeit. Either way these products were all illicit tobacco products, sales of these products in the UK are illegal.
- 7) Little Europe, Midland Road, Wellingborough was visited on the 10<sup>th</sup> and 30<sup>th</sup> of September 2021 and the 13<sup>th</sup> of January 2022.
- 8) On the 10<sup>th</sup> of September 2021 a packet of 20 Richmond cigarettes were purchased for £5.00.
- 9) On the 30<sup>th</sup> of September 2021 two packets of 20 Winston cigarettes and one packet of 20 Richmond cigarettes were purchased for £19.00.
- 10) On the 13<sup>th</sup> of January 2022 two packets of 20 Winston cigarettes were purchased for £13.00.
- 11) All the purchased products were illicit.
- 12)In response to the information that JTI UK supplied to Northamptonshire Police a compliance visit was conducted on the 26<sup>th</sup> of January 2022 by PC 113 Bryan and colleagues from North Northamptonshire Trading Standards Department, the premises was visited at approximately 11:00am.
- 13)On entering the premises there was one male customer present who was stood in front of the shop counter, one male member of staff was behind the counter, directly behind the member of staff was a door which had a keypad lock.
- 14) PC 113 Bryan identified himself and immediately walked behind the counter 'stuffed' halfway under the door was a black plastic bag, on looking inside it contained 6 packets of 20 L&M cigarettes, non duty paid. PC 113 Bryan seized the cigarettes and as he did he could hear what would be described as a commotion from behind the door. PC 113 Bryan asked the member of staff to open the door, the male entered an incorrect code initially but then on the second attempt the correct code was entered. As PC 113 Bryan entered through the door he noticed that the room had a staircase leading down to a basement at the far end of the room. PC 113 Bryan could hear a

person running down the stairs, he also ran down the stairs and when he got to the bottom he noticed a door that was closing, he went through this door which lead to an alleyway, as he entered the alleyway he could see a gate closing which lead onto Midland Road, he opened this gate and went through however Midland Road was busy with pedestrians so he could not identify who this person could have been. PC 113 Bryan exhibits three images taken of the room DB/1, DB/2, and DB/3, no other cigarettes legal or illicit were found on the premises.

- 15)PC 113 Bryan returned to the shop and spoke with the member of staff (details have been obtained and verified), the member of staff has the right to work in the UK and stated he was paid £10.00 an hour.
- 16)PC 113 Bryan then asked where the Premises Licence Holder Mr Faraidoon Marouf was, the member of staff stated that they had never heard of this person. PC 113 Bryan noticed that the Summary of the Premises Licence was part displayed on the wall behind the counter. PC 113 Bryan then removed page two of the summary and showed the member of staff the details of the Premises Licence Holder again the member of staff stated they had never heard of Mr Faraidoon Marouf.
- 17)I then asked the male member of staff, does the premises have CCTV, the member of staff stated that the cameras had been removed and the premises does not have CCTV. There is a condition on the Premises Licence that states 'CCTV will be in operation'. I exhibit images of the Premises Licence summary as DB/4 and DB/5.
- 18)A Companies House enquiry was made which shows that Little Europe Wellingborough Ltd, 15 Midland Road, Wellingborough is still an active company. However the Premises Licence Holder Mr Faraidoon Marouf resigned as the sole Director on the 29th of June 2018, a new Director was appointed on the same date a Mr Taha Rashed Hassan.

As the sale of illicit tobacco is illegal and closely linked to serious organised criminality a number of these stores may be considered to be undermining one of the objectives of the Licensing Act 2003, namely "The prevention of crime and disorder".

To support the licensing authority in assessing the potential risk of licensing premises engaged in illicit trade, I disseminated information to Northamptonshire Police Alcohol Licensing Team & North & West Northants Trading Standards.

Little Europe 15 Midland Road, Wellingborough NN8 1HA is a retail premises that sells alcohol and was visited on two separate occasions.

On the 10th & 30th September 2021 & the 13th January 2022 service providers entered Little Europe 15 Midland Road, Wellingborough NN8 1HA and undertook test purchases buying items from persons working behind the shop counter.

10/09/21 1210hrs - One (1) pack of 20 Richmond Cigarettes purchased for a total of £5.00. Exhibit EVE1/5086/10/09/21(2) refers as pictured.



Exhibit EVE1/5086/10/09/21(2) is not a JTI branded product, so I am unable to comment on its authenticity as a representative of the trademark owner.

I have visually examined the packaging which does not comply with current UK plain packaging legislation and does not indicate that UK Duty has been paid.

Open-source research conducted on the 29th January 2022 indicated that 20 Richmond Original cigarettes retail in UK Supermarket Asda at £9.75.

The examination of the Winston Cigarettes within Exhibit EVE1/5086/30/09/21(2) indicates that there are Genuine products produced by the JT International group for sale in the Polish Domestic market. As they were not produced for sale within the UK market they do not comply with current UK plain packaging legislation and do not indicate that UK Duty has been paid. The recommended retail price for 20 Winston Blue cigarettes within the UK market is £10.60.

13/01/22 1205hrs – Two (2) packs of 20 Winston Cigarettes purchased for a total of £13.00 Exhibit EVE1/5086/1205/13/01/22 refers as pictured.



The examination of the Winston Cigarettes within Exhibit EVE1/5086/1205/13/01/22 indicates that there are Genuine products produced by the JT International group for sale in the Polish Domestic market. As they were not produced for sale within the UK market they do not comply with current UK plain packaging legislation and do not indicate that UK Duty has been paid.

The recommended retail price for 20 Winston Blue cigarettes within the UK market is £10.60.

The Trade Mark WINSTON for cigarettes and tobacco products is owned in the UK by JTI International SA (a member of the JT International group of companies and an affiliate of Gallaher Limited).

We very much welcome the valuable work Police and Trading Standards do in tackling the sale of illegal tobacco, despite the financial and resource pressures they face.

This work is vital in safeguarding legitimate businesses and consumers.

The Intellectual Property Office's report (Trading standards successes. IP crime and enforcement report 2019 to 2020. IPO, September 2020) on the enforcement activity undertaken by Trading Standards departments shows that cigarettes and tobacco remain their most investigated product group.

HM Revenue & Customs (HMRC) estimate that the sale of illegal tobacco products in the UK has resulted in a tax revenue loss of more than £47 billion since 2000 (Measuring Tax Gaps 2020 edition – tax gap estimates for 2018 to 2019. HMRC, July 2020). HMRC also acknowledges that the sale of illegal tobacco "damages legitimate business, undermines public health and facilitates the supply of tobacco to young people" (Tackling illicit tobacco: From leaf to light. The HMRC and Border Force strategy to tackle tobacco smuggling. HMRC/Border Force, March 2015).

It has been widely reported that illegal tobacco is linked to other forms of criminality. For example, an article in the Chartered Trading Standards Institute's journal stated that "the illegal tobacco trade has strong links with organised crime and criminal gangs; many of the people smuggling, distributing and selling illegal tobacco are involved in drug dealing, money laundering, people trafficking and even terrorism." (Elite sniffer dog threatened by gangs, Journal of Trading Standards, January 2019.)

A high percentage of tobacco seized by the authorities entering the UK is raw unprocessed tobacco which indicates a significant level of illegal counterfeit production within the UK.

In recent years, JTI has seen through the work of its Anti Illicit Trade Organization (AITO) that the UK had several active fulfilment (illegal production) houses often staffed by persons working & living terrible conditions of servitude.

Fulfilment houses are often HMO (House Multiple Occupancy) where Organised Crime Group's (OCG's) lodge persons to stuff low quality ungraded tobacco into counterfeit pouches in unsanitary conditions. Oppressed workers producing fake product in often appalling working conditions are what allows the OCGs to keep costs low and maximise their profit.

OCG's invest in tobacco as they have the free unregulated connections to finance the criminal purchase of materials and labour. They have the well-established methods of concealment, smuggling routes, money laundering and the ability to use force to protect highly profitable criminal activity from criminal competitors.

Crime groups often use funds to finance the illegal tobacco trade which come from the sale of drugs, guns, and prostitution.

They also deploy the skills and modus operandi from those criminal activities in the illegal tobacco trade. The illegal tobacco trade seems to be in nearly every town which means organised crime is active in nearly every community.

Members of the public buying 'cheap cigarettes' unwittingly support regional, national and international OCG's.

Therefore, I would respectfully suggest that the continued sales of illegal tobacco products from Little Europe 15 Midland Road, Wellingborough NN8 1HA acts as a contributing factor to tax revenue loss, damages legitimate businesses and encourages wider criminality.

bags situated nearby. I could hear noises of a person running down a staircase and beyond the chair was an open door which lead down to a basement store room. I ran down the stairs and as I got to the bottom I could see another door which was closing in front of me. I managed to stop the door closing and ran through into a yard which lead to an alleyway. I ran into the alleyway and again I saw a door which lead out onto Midland Road closing, I ran to this door and then onto Midland Road, however whomever it was that was running away I could not identify as Midland Road was busy with pedestrians. I returned into the shop via the front entrance the male customer was no longer there I then spoke with the member of staff, he gave his details and identification. The male had the right to work in the UK, he did not talk about the cigarettes or about the person who was in the store room. I asked him where the Premises Licence Holder was, the male did not know who the licence holder was, I located the Premises Licence Summary behind the counter and on page two showed the details of the Premises Licence Holder, Mr Faraidoon Marouf, the male again stated that he had never heard of this person. At this stage I noticed that there was only one visible CCTV camera that was above the front door and faced inwards towards the counter. I could see where CCTV cameras had been removed from other areas within the shop, I asked the male did the shop have a working CCTV system to which he replied no the cameras had been removed. I informed the male that there was a condition on the Premises Licence that CCTV will be in operation, he made no reply. Whilst I was dealing with the male my Trading Standards collegues were dealing with the seized cigarrettes and their associated paperwork the cigarettes were retained by Trading Standards, no further illicit tobacco products were discovered. Once all the relevant paperwork had been completed we left the premises and returned to Wellingborough Police Station.




I am employed by North Northamptonshire Council Trading Standards Service as a Trading Standards Officer, based at Deene House, Corby. On 26th January 2022. accompanied by my colleague Luke TREWIN, we met with PC 113 BRYAN an Alcohol Licensing Constable with Northamptonshire Police. We carried out a joint inspection of Little Europe, 15 Midland Road, Wellingborough, NN8 1HA. The above colleagues and I entered Little Europe at approximately 11:15, where we introduced ourselves and showed our identification to the male behind the till area. PC Bryan went behind the till area and handed me a small black carrier bag which he had picked up off the floor I then noticed there was a gap between the door and the floor. PC Bryan tried to open the door behind the till, but it was locked and had a key code lock, PC Bryan asked the male to open the door which he did after two attempts to get the correct door code. PC BRYAN and Mr TREWIN went through the door and into a storeroom area. I followed shortly after, PC BRYAN advised me he could hear some movement from behind the door prior to him entering the storeroom. I then spoke to the male occupying the premises, at the time we entered, he gave me his name as Mr Sarwan Rasul HAMADI, he described himself to me as staff. Inside the bag that PC BRYAN handed me was 6 packets of 20 L&M Cigarettes, which I seized and produce as exhibit JCM/77251/1. 

HAMADI. PC BRYAN, Mr TREWIN and I then left the premises. The exhibits were then logged into the secure store.








