1. Purpose of Report

- 1.1 To consider if any interim steps are required following application by Northamptonshire Police for summary review of the Premises Licence for Quality Food 4 You trading as Braces News, 99 -101 Montagu Street, Kettering.

2. Executive Summary

- 2.1 An application for summary review of the premises licence for Quality Food 4 You trading as Braces News, 99-101 Montagu Street, Kettering was received from Northamptonshire Police at 11.22 a.m on Tuesday 28 November 2023.
- 2.2 The summary review process is an expedited process within the Licensing Act 2003 where there must be evidence of serious crime or serious violence or both.
- 2.3 The process has two stages, an initial interim steps consideration which must be carried out within 48 hours of the application being received followed by a formal review hearing within 28 days of the application being received.
- 2.4 This hearing is to consider the interim steps.

3. Recommendations

- 3.1 The Committee is asked to consider the application from Northamptonshire Police and, if it considers that the application meets the requirements for

summary review, to consider what action, if any, to take immediately with regards to the premises licence.

- 3.2 The actions that the Authority may take as interim steps are to modify the licence conditions, exclude the sale of alcohol, remove the DPS or suspend the licence. Consideration should be given to any recommendation from Northamptonshire Police in this matter.

4. Report Background

- 4.1 An Application for Summary Review of the Premises Licence for Quality Food 4 You trading as Braces News, 99 - 101 Montagu Street, Kettering has been received from Northamptonshire Police. A copy of the certificate and the application required under the legislation are attached.
- 4.2 The application is submitted under the amendments to the Licensing Act 2003 by the Violent Crime Reduction Act 2006. This power provides an expedited review process in certain circumstances.
- 4.3 The Committee must be satisfied that there is evidence of serious crime or serious violence or both. The crime must be sufficiently serious to carry a sentence of imprisonment for 3 years or more for an individual over 18 with no previous convictions. The certificate and application describe this evidence.
- 4.4 The amended legislation gives powers to the Licensing Authority to take interim steps following application prior to a full review hearing being held.
- 4.5 The Authority may consider for these interim steps modifying conditions, excluding the sale of alcohol, removing the DPS or suspending the licence.
- 4.6 Any decision is effective from the hearing.
- 4.7 The Licence holder cannot appeal through the courts against the implementation of interim steps but may make representation to the Licensing Authority against the decision.
- 4.8 A full review hearing must be held within 28 days from the day the review application is received.

5. Issues and Choices

- 5.1 Having considered the information provided by Northamptonshire Police the Committee must consider the options available to it as detailed above and take such action as it considers necessary to address the concerns raised in Northamptonshire Police's application.

6 Implications (including financial implications)

6.1 Resources and Financial

6.1.1 There are no resource or financial implications in relation to this report

6.2 Legal

6.2.1 The Summary review process is detailed within Section 53A to 53D of the Licensing Act 2003 and Chapter 12 of the Section 182 Guidance issued under the Licensing Act 2003.

6.2.2 There is no right to appeal the decision of the Committee in relation to the interim measures. The Licensee may make representation to the Licensing Authority against any decision at this stage and will have the right to present his case at the review hearing to follow.

6.2.3 A hearing date within 28 days from the date of the application must be set.

6.3.1 There are no significant risks arising from the proposed recommendations in this report.

6.4.1 There is no legal consultation process relating to this particular process.

Notes for guidance:

1. A certificate of the kind mentioned in the form must accompany the application in order for it to be valid under the terms of the Licensing Act 2003. The certificate must explicitly state the senior officer's opinion that the premises in question are associated with serious crime, serious disorder or both.

Serious crime is defined by reference to section 81 of the Regulation of Investigatory Powers Act 2000. In summary, it means:

- conduct that amounts to one or more criminal offences for which a person who has attained the age of eighteen and has no previous convictions could reasonably be expected to be sentenced to imprisonment for a term of three years or more; or

- conduct that amounts to one or more criminal offences and involves the use of violence, results in substantial financial gain or is conduct by a large number of persons in pursuit of a common purpose.

Serious disorder is not defined in legislation, and so bears its ordinary English meaning.

I am giving this certificate because I am of the opinion that other procedures under the Licensing Act 2003 are inappropriate in this case because:

Serious crime: The tests to determine the kinds of conduct that amount to serious crime are set out in section 81(2) and (3) (a) and (b) of the Regulation of Investigatory Powers Act 2000. Those tests are that the conduct: (a) constitutes an offence for which a person who is 21 years of age or over with no previous convictions could reasonably be expected to be sentenced to imprisonment for 3 years or more; or (b) Involves the use of violence, **results in substantial financial gain** or is conduct by a large number of persons in pursuit of a common purpose.

On the 8th of November 2023 Officers from Northamptonshire Police and North Northamptonshire Council Trading Standards Department attended Braces News

and Off-Licence during an intelligence led operation regarding the criminal activity of the sale and/or storage of illicit tobacco products.

In the kitchen area of the back store room a conceal compartment (hide) was discovered. Within the hide the following was discovered;

5104 Packets of duty not paid cigarettes, estimated value based on a packet of legal duty paid cigarettes is £74,518.40.

81 Packets of 50g Hand Rolling Tobacco estimated value based on a legal duty paid packet of HRT is £2721.60.

The total being £77,240.00

Tobacco Duty on a single packet of cigarettes is 16.5% of the retail price plus £5.89, TSD used the figure of a packet of duty paid cigarettes being £14.60. This would mean the revenue on a single packet would be £8.29.

The revenue lost due to no duty being paid on the smuggled cigarettes equals £42,312.16.

The duty on HRT is £351.03 per 1000 grammes, the total in grammes seized was 4050, the estimated lost revenue £1579.00

The total duty not paid is estimated at £44,891.16

Section 144 of the Licensing Act 2003 A person commits an offence if he knowingly keeps or allows to be kept, on any relevant premises, any goods which have been imported without payment of duty or which have otherwise been unlawfully imported.

In addition point 11:27 of the Statutory section 182 guidance that accompanies the Licensing Act 2003 details certain criminal activity that may arise in connection with licensed premises which should be treated as particularly serious, one of the activities listed is the sale or storage of smuggled tobacco and alcohol.

If this premises licence authorises the supply of alcohol, the following conditions must be complied with:

1. No supply of alcohol may be made under the premises licence—
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence
3. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

- (a) a holographic mark, or
 - (b) an ultraviolet feature.
4. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

If this premises licence requires the use of door supervisors.

5. Where the premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must
 - (a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
 - (b) be entitled to carry out that activity by virtue of section 4 of that Act.

Explanatory Notes and Definitions for Mandatory Condition 8.

Definitions

“duty” is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

“permitted price” is the price found by applying the formula—

$$P = D + (D \times V)$$

where—

- (i) P is the permitted price,
- (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

“relevant person” means, in relation to premises in respect of which there is in force a premises licence—

- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

“valued added tax” means value added tax charged in accordance with the Value Added Tax Act 1994.

Where the permitted price calculated would not be a whole number of pennies, it shall be taken to be the price calculated rounded **up** to the nearest penny.
