53 Apologies for absence

There were none.

54 Minutes of the meeting held on Wednesday 15 December 2021

Resolved that:

The minutes of the meeting held on 15 December 2021 be approved as correct record and signed by the Chair.

55 Declarations of Interest

The Chair invited those members who wished to do so to declare any interests in respect of items on the agenda.

No interests were declared.

56 Proposed amalgamation of Tennyson Road Infant and Alfred Street Junior Schools

The Chair welcomed to the meeting local members for Rushden Pemberton West and Rushden South and invited them to participate in the discussion for this item.

the At the Chairman's invitation the Assistant Director for Children introduced the report (a copy of which had been previously circulated) which stated details of the proposed amalgamation of the 2 schools, the reasons for them and the need to understand the feelings of all those affected by the proposal. This was listed as item 4 on the agenda.

In answer to queries on the report the following was confirmed:

- i. Officers working in education were working with the governing bodies of both schools and the Assistant Director of Education had met with Chairmen of both governing bodies.
- ii. Amalgamation would provide the best possible solution for both schools to meet the needs of all pupils.
- iii. When any school operated a deficit position the Council did not just stop funding. The Council worked with the school and the Department for Education (DfE) to ensure there was a financial recovery plan to re-balance the budget.
- iv. The first consultation would be just on the decision on whether to merge or not. The second consultation (26 May to 23 June) depending on the result of the first consultation would then identify a site for expansion.
- v. There was no suggestion that both schools would close with no replacement. The options were to do nothing, close one school and expand the other or close both and build a new school.
- vi. No pressure would be placed on other schools as they were receiving fewer admission requests than the published admission numbers (PAN) of local schools.
- vii. Paragraph 7.5.2 of the report gave the timeline for the DfE process that had to be followed.
- viii. The Council was duty bound to consider the financial recovery model with the School, governors and the DfE. They would not rule anything out at this stage and if it was a suggestion that was in the best interests of the schools it would be considered.
- ix. The cost of the consultation was something that the Council would lead on and which would come from the school organisation budget.
- x. If both schools were closed and a new one opened, regulations would dictate that it would be an academy and the Council would have to discuss this with the DfE. If the schools merged, the merged school would continue in the same format as currently existed.
- xi. The steering group referred to in paragraph 4.14 of the report was a group driven by the Chairmen of both sets of school governors and staff at both schools. It was being supported by officers at the local authority, but was not a decision-making body.

- xii. The Council would work with both schools to ensure a full and extensive curriculum was continued to be offered to pupils.
- xiii. It was noted by councillors that a merger had been discussed for many years. There had at one time been a keenness by local people to keep Alfred Street School because of the number of pupils who had died when a war time bomb had hit the school. Also this area of Rushden had become less populated and the catchment area for the 2 schools had changed. Many pupils now had to cross 2 major and dangerous roads and there were inadequate facilities for parents to drop pupils off, particularly pupils with special educational needs. It was felt the site of Tennyson Road School could be expanded whereas the site of Alfred Street could not. It was also suggested that some additional land could be bought from the Council to expand Tennyson Road.
- xiv. It was further noted that all of the Tennyson Road site was owned by North Northants Council. The parking in the Pemberton Centre was managed as a North Northants facility too. The Alfred Street Site had been owned by East Northants Council and had transferred to North Northants Council.
- xv. Councillors also noted that the right decision for North Northants Council had to be made as well to ensure its future stability.

Resolved that: The Executive Advisory Panel:

- a) Supports the progress of the statutory process relating to the amalgamation of the Tennyson Road and Alfred Street schools;
- b) Supports the consultation on the potential location of the proposed 'new' school; and
- c) Notes that a follow-up EAP report will be provided for further consideration during the second period of consultation, subject to Executive's approval of the overall process.

57 Determination of admission arrangements for local authority maintained schools for the 2023 intakes

At the Chair's invitation the Interim Assistant Director of Children presented the report (a copy of which had been previously circulated) which gave details of the Community and Voluntary Controlled North Northamptonshire schools for 2023 intakes and the Primary and Secondary Co-ordinated Schemes for the 2023 intakes. This was listed as agenda item 5 on the agenda.

In answer to queries on the report the following was confirmed:

- i. Some schools did opt out of and the Interim Assistant Director of Children could find out the exact number following the meeting.
- ii. There was a home to school transport policy as the Council did support children that qualified for assistance in paying for travel arrangements. However, subject to minimum distance requirements, this was only for children where a place could not be offered at their nearest school. For those who chose a

school that wasn't their nearest this would be deemed parental choice and they would not qualify for assistance

- iii. Some schools might reduce their published number to admit if the local authority was confident they were unlikely to require a higher number as this assisted them to budget for the future if they were not required, for example, to open a second class. The Local Authority's responsibility was to ensure there were adequate places in an area. Not individual schools. Keeping an eye on changes in demography allowed schools to plan for the future.

Resolved that:

The Executive Advisory Panel notes proposals to be submitted to the Executive on:-

- a) admission arrangements as detailed in Appendix A to the report.
- b) two co-ordinated schemes for the 2023 intake as detailed in Appendices B and C to the report; and
- (c) the "Relevant Area" for all North Northamptonshire schools

1. Purpose of Report

- 1.1. The purpose of this report is to provide Members with all the necessary information to make a fully informed decision in respect of the funding and future provision of school holiday food vouchers for the 2022 Easter and May half-term holiday periods. The report will provide the following detail;
- Number of eligible children and young people resident in North Northants;
 - The cost to the Council of providing school holiday food vouchers;
 - The process utilised to distribute vouchers to eligible families.

2. Executive Summary

- 2.1 Northamptonshire County Council (NCC) began to provide school holiday food vouchers to children and young people eligible for benefits related Free School Meals in October 2020, in an effort to ensure that vulnerable families were supported during the Coronavirus pandemic. From 1st April 2021, North Northamptonshire Council (NNC) has continued this support in all subsequent school holiday periods.

- 2.2 The number of children and young people eligible for benefits related Free School Meals (FSM) has increased throughout the Coronavirus pandemic, currently 10,095 individuals are eligible (as of 20th January 2022) however, this situation is very fluid and is highly likely to increase.
- 2.3 The Department for Education (DfE) standard rate for the provision of FSM is £15 per pupil per week and this is the value that NNC has utilised when providing school holiday food vouchers.
- 2.4 The cost of providing school holiday food vouchers during the Easter holiday period to NNC would be £306,000, with a further £153,000 required to fund vouchers at May half-term (allowing for a small increase in the number of eligible children and young people between now and the school holidays).

3. Recommendations

- 3.1 It is recommended that the Executive:
- a) Approve the funding of school holiday food vouchers for the 2022 Easter school holiday period at a cost of £306,000, from the 'Household Support Grant' received from central government for the purpose of providing financial support to vulnerable families during the pandemic.
 - b) Approve the provision and funding of school holiday food vouchers for the 2022 May half-term period, at a cost of £153,000 from the 'Household Support Grant' received from central government for the purpose of providing financial support to vulnerable families during the pandemic.
- 3.2 Reasons for Recommendations:–
- Customers will receive the maximum benefit from the option proposed and it will provide support to financially disadvantaged residents of North Northamptonshire during school holiday periods.
 - The recommendation is consistent with previous decisions taken by the Council.
 - Use of the 'Household Support Grant' for this purpose is compliant with the terms of the grant.

4. Report Background

- 4.1 The Council has partnered with a company named 'Huggg', an online voucher distribution platform, to facilitate the distribution of school holiday food vouchers to eligible families across North Northamptonshire, since the unitary authority was established in April 2021. Voucher codes to the value of £15 per child, per week were generated via the 'Huggg' platform and then sent to individual schools for onwards distribution to families.
- 4.2 Families in receipt of a school holiday food voucher have been able to utilise the voucher at the following retail outlets; Aldi, Asda, Marks and Spencer, McColls Newsagents, Morrisons, Sainsbury's and Tesco.

4.3 Since the 1st April 2021, the Council has funded the following amounts of school holiday food vouchers to support financially disadvantaged families during the pandemic;

- Easter 2021: £300,000;
- May half-term 2021: £150,000;
- Summer 2021: £900,000;
- October half-term 2021: £150,000;
- Christmas 2021: £300,000;
- February half-term 2022: £150,000;
- Total: £1,950,000.

4.4 The Council received a total of £2,508,248 as its allocation of the 'Household Support Grant'. The terms of the grant require that at least 50% of the grant is used to support families with children and the proposal to use this grant to fund school holiday food vouchers is fully compliant with the terms of the grant.

5. Issues and Choices

5.1 To fund school holiday food vouchers from the 'Household Support Grant' for the Easter and May half-term holiday period: This option would allow the Council to provide financial support to residents of North Northamptonshire that require it most during the pandemic, whilst complying with the grant conditions for its use. This option has no impact on the Council's general fund.

5.2 To fund school holiday food vouchers from the 'Household Support Grant' for the Easter but not May half-term holiday period: This option would allow for partial financial support to be provided to financially disadvantaged families, whilst complying with the grant conditions. This option may mean that the Council is unable to utilise the full amount of the 'Household Support Grant' funding received from central government. This option would also be inconsistent with other decisions made in relation to the provision of school holiday food vouchers in the 21/22 academic year.

5.3 To fund school holiday food vouchers from another source: Whilst this option would allow the Council to support financially disadvantaged families resident in North Northants, no other funding stream has been identified for this purpose and would impact upon the NNC general fund. No alternative use has been identified for the 'Household Support Grant' and progression of this option may result in grant funding being returned to central government.

5.4 To not fund school holiday food vouchers: This option would not allow the Council to provide financial support to disadvantaged residents of North Northamptonshire.

6. Implications (including financial implications)

6.1 Resources and Financial

- 6.1.1 Use of £459,000 of 'Household Support Grant' funding for the provision of school holiday food vouchers for the 2022 Easter and May half-term school holiday periods would not have any financial implications for the Council as the proposal is to use grant funding received from central government for this purpose. The proposal will not have any impact upon the Council general fund.
- 6.1.2 The Free School Meals Administration Service would be utilised to distribute voucher codes to schools for onwards distribution to families. The team is in place and has distributed vouchers for all previous school holiday periods. The resources for progression of this option are already in place and no further resource would be required.

6.2 Legal

- 6.2.1 The use of the funds is compliant with the grant conditions as set out in the report. It is an Executive function to agree to provide Free School Meals vouchers. The grant forms part of the Council's Budget and Policy Framework and therefore is an Executive function.

6.3 Risk

- 6.3.1 There are no significant risks to the Council that would arise from this proposal.

6.4 Consultation

- 6.4.1 No consultation was required or undertaken in respect of this proposal.

6.5 Consideration by Scrutiny

6.7 Community Impact

- 6.7.1 The community impact of this proposal would be positive, as it seeks to provide financial support to disadvantaged families across North Northamptonshire that they otherwise would not receive.

INTRODUCTION

This is the North Northamptonshire Council's Forward Plan. It is published pursuant to The Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012. Its purpose is to provide the required 28 days notice of the Council's intention to take 'key decisions' and to hold meetings or parts of meetings in private. It gives advance notice of all the "key decisions" and "exempt decisions" which the Executive or another body or officer so authorised are likely to take over a four month period. The Plan is updated on a rolling monthly basis.

The concept of a "key decision" is intended to capture the most important or significant decisions. "Key decisions" will normally be made at meetings open to the press and public. The press and public will only be excluded from such meetings as and when the Council's Monitoring Officer considers that this is necessary in order to avoid the public disclosure of confidential or exempt information.

The authority has decided that a Key Decision is one which is likely:-

- (a) to result in the authority incurring expenditure of which is, or the making of savings which are, significant; or
- (b) to be significant in terms of its effects on communities living or working in an area comprising two or more electoral wards in the area of the authority."

The Council has decided that significant expenditure or savings are those amounting to above £500,000.

In determining the meaning of "*significant*" for these purposes North Northamptonshire Council will also have regard to any guidance for the time being issued by the Secretary of State in accordance with section 9Q of the Local Government Act 2000.

At times it may be necessary for the North Northamptonshire Council to give consideration to items where the public may be excluded from the meeting. Members of the public are excluded from meetings whenever it is likely that, in the view of the nature of the business to be transacted or the nature of the proceedings that confidential information would be disclosed. This includes exclusion from access to any pertinent documents. Details of the exemption categories can be found in the 'Access to Information Procedure Rules' section in the Council's [Constitution](#). This plan provides advance notice of any items which may be held in private.

Paragraph 5 of the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012 provides for members of the public to make representations to the Council on why an exempt item should be considered in public, rather than in private. Persons wishing to make such representations and/or obtain further details in respect of any issues referred to in the Plan should contact the undermentioned officer.

The Monitoring Officer may also include in the Forward Plan references to such other decisions, which are to be taken by the Council or any of its Committees or Sub-Committee or officers as they consider appropriate. These will be those decisions that are considered to be significant or sufficiently important and/or sensitive so that it is reasonable for a member of the public to expect it to be recorded and published.
