1.1 The Executive are recommended to note the urgent decision taken by the Leader of the Council and the Chair of Scrutiny Commission, in consultation with the Portfolio Lead for Adults, Health and Wellbeing and underwritten advisement from the Chief Executive, Monitoring Officer or S151 officer, using their powers under the special urgency provisions at section 6 of the Council's Constitution, in order to:

a) Approve the described approach to procure the Older Person's Residential and Nursing Care Dynamic Purchasing System (DPS) for a period of 1 year from 01 September 2021 until 31 August 2022 using the Light Touch Regime (CPR 2015); and



b) Delegate this activity to the Executive Director for Adults, Communities and Wellbeing in consultation with the Portfolio Lead for Adults, Health and Wellbeing

#### 2. Purpose

2.1. To notify the Executive of the urgent decision taken in order to enable the commencement of procurement exercise to re-tender a short-term Dynamic Purchasing System DPS due to exceedingly tight timescales that meant it was not possible to bring the decision to the first formal Executive meeting of the new council.

#### 4. Reasons for Special Urgency
