# 1. Purpose of Report

1.1 To provide the Joint Committee with an update on Northamptonshire Children's Trust's (NCT) progress to deliver agreed savings as part of the Contract Sum for 2023/24.

# 2. Executive Summary

- 2.1 In accordance with the Service Delivery Contract (SDC) the Councils agreed a proposed 2023/24 Contract Sum with NCT for the delivery of its' services at the meeting of the Strategic Group in November 2022.
- 2.2 The 2023/24 Contract Sum included savings put forward by NCT of £7.672m.

- 2.3 NCT reported their progress to deliver the agreed savings in their P3 finance report presented to Operational Group in August 2023 with £4.202m of the £7.672m flagged at risk of non- delivery.
- 2.4 Agreed savings in the Contract Sum are netted off the Trust's budget meaning that non-delivery of any savings would be reflected as a pressure in the outturn for 2023/24 and it is likely that the Councils will have to fund this unless mitigations are found by NCT.
- 2.5 NCT's P3 finance report presented to Operational Group in August 2023 forecasted a pressure above the agreed Contract Sum for 2023/24 of £22.186m. It should be noted that this does not include savings that NCT have reported will not be delivered or are at risk of non-delivery which amounts to £4.202m. In addition, NCT have flagged further potential pressures and mitigations that have not been reflected in the forecast outturn position reported at P3.

# 3. Recommendations

#### 3.1. It is recommended that the Children's Trust Joint Committee:

a) Note NCT's current forecast to deliver agreed savings as reported at P3 to Operational Group in August 2023.

#### 3.2. Reason for Recommendations

- The Councils have established the Children's Trust Joint Committee to discharge the functions of the Councils that relate to ownership of NCT, the provision of support services to the Trust and consider relevant matters arising in relation to the delivery of children's early help and social care services and their financial position.
- The recommendation in this report provides the Joint Committee with oversight of the delivery of NCT's agreed savings for 2023/24 which contributes to the overall financial position.

# 3.3. Alternative Options Considered

 Do nothing - Not allowing the Joint Committee appropriate oversight of the delivery of NCT's agreed savings for 2023/24 would prevent them from discharging the Councils responsibilities to monitor NCT's financial position.

# 4. Report Background

4.1 Following a statutory direction from the Secretary of State for Education, Northamptonshire County Council was required to oversee work towards the establishment of a Trust for the delivery of children's social care services in Northamptonshire, transferring operational control for children's social care services from the Council to the Trust. Upon the creation of the two new unitary Councils, the

commissioning and ownership of NCT was transferred to North and West Northamptonshire Councils.

- 4.2 As part of the establishment of NCT, a suite of contractual agreements were put in place to govern the relationship between NCT and the Councils. The core contractual agreement is the Service Delivery Contract and its associated schedules.
- 4.3 As required by the SDC the Councils agreed a proposed 2023/24 Contract Sum with NCT for the delivery of its' services at the meeting of Strategic Group in November 2022.
- 4.2 The Councils agreed the proposed 2023/24 Contract Sum as part of their budget setting processes in February 2023.
- 4.3 The 2023/24 Contract Sum included savings put forward by NCT of £7.672m.
- 4.4 NCT reported their progress to deliver the agreed savings in their P3 finance report presented to Operational Group in August 2023 as set out in the table below.

- 4.5 As set out in the table above as at P3 NCT have reported that £4.202m of the £7.672m proposed savings are at risk of non delivery. A total of £1.247m has been RAG rated as Red meaning that these will not be delivered in year and an amount of £2.955m has been RAG rated as Amber meaning that these are at risk of not being delivered.
- 4.6 Agreed savings in the Contract Sum are netted off the Trust's budget meaning that non-delivery of any savings would be reflected as a pressure in the outturn for 2023/24 and it is likely that the Councils will have to fund this unless mitigations are found by NCT.
- 4.7 NCT's P3 finance report presented to Operational Group in August 2023 forecasted a pressure above the agreed Contract Sum for 2023/24 of £22.186m. It should be noted that this does not include savings that NCT have reported will not be delivered or are at risk of non delivery which amounts to £4.202m. In addition NCT have flagged further potential pressures and mitigations that have not been reflected in the forecast outturn position reported at P3.

#### 5. Issues and Choices
