| Decision                                    | That the Leader of the Council:   |  |
|   | Approves the funding of Free School Meals vouchers for those children eligible for free school meals and who attend school in North Northamptonshire for the October half-term.   |  |
| Reason for Decision                         | To support vulnerable families that are eligible for benefits related Free School Meals with the purchase of food during the school holiday periods identified above. This is a limited extension of the decision to fund Free School Meals vouchers in holiday periods during the 20/21 academic year. |  |
| Alternative options rejected                | To not fund Free School Meals vouchers. This decision was rejected as it would not have provided support to vulnerable families within the North Northamptonshire area for these school holiday periods.  |  |
|   | The Leader has authority to make executive decisions on behalf of the authority. The decision is within the budget and policy framework agreed as set out within financial implications.  |  |
| Legal implications                          | Due to the timeframe to ensure that the vouchers are administered, the decision has not been published as a Key Decision. The Scrutiny Chairs have agreed to the decision being taken under "Special Urgency Rules" contained within the Access to Information Procedure Rules within the Constitution. |  |
| Financial implications                      | The number of children and young people eligible for benefits related Free School Meals that reside in North Northants equals 10,000.   |  |
